

Batheaston Parish Council Minutes of a Meeting of the Finance Committee held at 8:00pm on Tuesday 21st January 2025 at the Rhymes Pavilion, Coalpit Road, BA1 7NW Present: Councillors Alexis Pavlou (Chair of the Committee), Peter Bryant, Arif Butt, and Sue Peachey.

PROCEDURAL MATTERS

- 1. Public participation: There were no member of the public present
- 2. There were no apologies for absence.
- 3. There were no declarations of interest from Councillors.
- **4. Council approved** the draft minutes of the meeting of the Committee held on Monday 16th December 2024.

FINANCE OPERATIONS

- 5. Transaction Approval
- **5.1.** The **Committee deferred** approval of the transactions undertaken up to December 2024.
 - 5.1.1. The Clerk will publish on the website.

5.2. The **Committee noted** that bank reconciliations have been signed by the Chair of the Committee to December 2024.

6. 2025/26 Budget and Precept

- **6.1.** The **Committee received** the updated report on finances to end of December 2024 and forecast for the end of the financial year 2024/25.
- **6.2.** The **Committee discussed** the potential impact on 2025/26 budget of the recommendations from the foregoing HR Committee meeting regarding resource changes, at £5,000 for the 6 months that is proposed to run from 1st April.
- **6.3.** The **Committee received** a report on existing recurrent expenditure commitments, and one-off commitments arising from approvals by Council, and projected income for 2025/26.
 - 6.3.1. They noted the need to improve communications services, such as the website and social media. It would be sensible to allocate increased investment.

- **6.4.** The **Committee discussed** the assumptions to be made regarding inflation, national pay rise, and other factors outside the Council's control.
 - 6.4.1. They agreed that allowing 4% for general inflation was prudent
 - 6.4.2. It is necessary to maintain, and ideally to increase, reserves to fund the significant projects that the Council wishes to undertake over the next year or more.
 - 6.4.3. The impact on householders should also be borne in mind; the important consideration is the rise that they will see in their Council Tax bills.
 - 6.4.4. The Committee therefore resolved to recommend that the Precept be set so that the increase from this year per household is 4%.
 - 6.4.5. The Precept request for 2025/26 will therefore be £135,420.
 - 6.4.6. Such an increase would create a fund of £60k for project investment.
