PROCEDURAL MATTERS

- 1. Council accepted apologies for absence from Cllr Butt, Gray and Skelton.
- 2. There were no declarations of interest from Councillors.
- **3.** A member of the Public Participation regarding item 9.3, Suffragette Memorial on the agenda.
 - **3.1.** Cllr Squire brought forward Item 9.3
 - 9.3 **To receive** a verbal report on the Suffragette Memorial Project Group, from Cllr McCarthy, Lead of the Project Group.
 - 9.3.1 Cllr McCarthy noted that there are many in the local community who wish to see it progress as she had planned.
 - 9.3.2 Cllr Squire reminded the meeting that the outcome of the previous meeting was that a Project Group would be established, with community input. This requires an amended Terms of Reference to be approved, which has not happened due to the focus of time on the Party.

- 6. Highways Transport and Planning Working Group

 - 6.1.1. She commented that in August there will be improvements undertaken to the lower section of Bannerdown Road and to Fiveways Roundabout by B&NES.
 - 6.1.2. Councillors noted that the A36 will be closed for up to 6 months from the autumn, which will result in diversion to the roads in and around Batheaston.

7.1. Cllr Lewis, Lead of the Working Group, gave a verbal report, noting that there had no progress on the river safety measures and the pontoon, and that he will prioritise this with the Clerk.

 - 9.2.2. Cllr Pavlou volunteered to discuss the option for the development of the kitchen that has been proposed by a local businessman.
